METHODOLOGY OF HISTORICAL COGNITION

P. 4. *Nikolaeva I.Y.* «**THE LAUGHTER AND THE TEARS**» OF THE AUTHORITY IN HISTORICAL CONTEXT OF ITS DYNAMICS. The main goal of this article to argument the period of government of Ivan IV was the time of the first stage of the Russian modernization which has «turned back» by historical failure. The author investigate psychohistorical roots of this failure. Nikolaeva analyzes a nature of chaotic and impulsive character of spent transformations, researches social-psychological complex of the features boldly traced at the initial stages of modernization, which finally determined its macrohistorical specificity. The hypothesis based on procedure of verification of received conclusions. It reveals an intrinsic organic interrelations between macrohistorical trends of social dynamics and emotional microhistorical phenomenon of cultural codes.

P. 30. *Nikolaeva I.Y., Mukhin O.N.* **AUTHORITY IN TRADITION SOCIETIES: PSICHO-SOCIAL AND CULTURAL SYMBOLICS.** In given article the attempt of the comparative analysis of authority mythologems stylistics and determinants of consciousness of Russian and West-European historical-cultural line is done. As a basis the problem of authority sacralization of the Russian, English and French medieval governors is taken. Examining the appropriate political and religious – cultural traditions in light of the methodological synthesis concept (in focus of consideration the unconscious sphere is acts), the authors come to a conclusion about the greater degree of sovereigns' images sacralization in socalled nonsynthesis zone and, on the contrary, ability to accelerated of desacralization of the authority relations in France, which has received antique infusion.

The study of the complex: of back-yard materials, stored in the National archive of Tomsk region, at with Russian and Siberian publications of consolidated facts of census are in the center of attention.
- P. 143. *Nozdrin G.A.* **SOCIAL PROTEST OF SIBERIAN PEASANTRY IN THE SECOND HALF OF XIX – AT THE BEGINNING OF XX CENTURY.** In the article the dynamics of peasant movement during the whole period of 1895–1914 is analysed, that made it possible to determine its peaks and abatement more exactly.
